Objectives of the University

The objectives of establishing the University are cited in Part II of the Ocean University of Sri Lanka Act, No. 31 of 2014 as follows.

01. To provide university education in the fields of Fisheries, Ocean Sciences, Maritime Technology and allied fields.
02. To offer vocational and technical courses of study relating to fisheries and allied fields in order to cater to the manpower needs in any area.
03. To disseminate knowledge relating to fisheries, marine and maritime sectors among persons who are engaged in fisheries and allied fields.
04. To provide for extension courses for continuous professional development in the fields of Fisheries, Ocean Sciences, Maritime Technology and allied fields.
05. To provide vocational and technical courses for personnel in the fields of fisheries and allied fields for admission to the University.
06. To provide for the progressive development of students in the fields of engineering, scientific, technical and vocational education and training systems, based on their aptitude and ability to acquire a university education in the fields of Fisheries, Ocean Sciences, Maritime Technology and allied fields.
07. To provide courses of study for those who possess National Vocational Qualifications and assist them to upgrade their competency and acquire academic qualifications in the fields of fisheries, ocean sciences, maritime technology and allied fields.

Vice Chancellor's Message



Making the year 2021 as another year to create a skilled workforce through the Ocean University of Sri Lanka, which engages in the pilot role of developing a Blue-Green Economy based on the ocean, I assumed the role of the fourth Vice-Chancellor of the University.

Our university, having identified the institutional role in the economic stabilization process of Sri Lanka, which is geographically located at a maritime hub on the ocean, plays a unique role in contributing to the society the human resources with the necessary training and skills for the effective utilization of marine resources. Accordingly, in view of achieving the above-mentioned objective, the Higher Education and Vocational Training Divisions of the university have given leadership in the planning and organizing process with a more effective future vision in the year 2021.

Marking a special juncture in academic and training work, as an initial step to create a skilled workforce within the university academic stream in order to build links between degrees and National Vocational Qualification (NVQ) levels, students were admitted having introduced the Bachelor of Technology degree programs in the year 2021.

Similarly, in 2021, through the granting of the contribution of Ocean University for the research-based M.Phil, Ph.D, and M.Sc degree awarding in addition to the degree programs implemented by the Higher Education Division, it had been able to expand the affairs of the Higher Education Division. Furthermore, the formulation of syllabuses for the new degree programs was also done in the year 2021.

Conferring degrees without holding convocation under sub-section (2) in terms of the guidelines on conducting the convocation in Part VII of the Ocean University of Sri Lanka Act marks in the history as a significant achievement in the year 2021 in the face of the Covid-19 epidemic. As the Covid-19 epidemic situation prevailed in Sri Lanka, this special convocation opened avenues for graduates to get various employment opportunities and post-higher educational opportunities.

Paying more emphasis on the priority areas of solving employee issues to strengthen the administrative structure of the university, strengthen the structures of the university, the introduction of new degree programs and vocational training courses, and modification of study programs and development of infrastructure within the year triggered the expansion of the role of the university.

The Finance Committee of the University, which was established in the year 2021, performs its duties with the objectives of allocation and utilization of public finance in a more transparent and effective manner. The Finance Committee consists of representations from the line ministry, and Department of National Budget and council members, and a university representation with financial knowledge.

In addition, arrangements were made to regularize the academic and administrative affairs by establishing Dean's Committees, Library Committees, Vessel Maintenance Committees, etc.

We can point out that our university has been engaged in a productive and efficient public service as the Audit Division confirmed that the financial utilization has been done effectively and in a transparent manner for the benefit of the public.

In the year 2021, it had been able to basically prepare the Environmental Impact Assessment Report (EIA Report) for the project report relevant to the obtaining of KOICA project grants with regard to the construction of permanent building premises for the Ocean University of Sri Lanka, and it can be considered as a significant juncture of the future pathway of the university.

In the year 2021, having contributed to sustainable developments through the study programs of Ocean University, it has made a value addition to the Marine, Maritime, and Fisheries sectors. Through the training provided by the university in the year 2022, I expect to work towards creating a human resource competent with skills with the assistance of all the staff of the Ocean University for solving various marine issues such as depletion of resources, unsustainable fishing practices, etc. as well as for securing a sustainable marine ecosystem by reducing the environmental pollution.

03. Overview

03.1 Inception, Development, and Objectives of the Ocean University of Sri Lanka



The Ocean University of Sri Lanka, which was established by Act No. 31 of 2014, plays the role of contributing to the development of the country by improving scientific, technical, and management skills and imparting knowledge to meet the labor requirements of the fisheries, marine and maritime sectors in Sri Lanka.

The origin of the journey to the Ocean University of Sri Lanka marks from the Negombo area. Having established in Negombo as the Fisheries Training Institute in 1963, after a gradual development of 06 Fisheries Training Centers respectively in Tanaglle, Batticaloa, and Jaffna in 1972, in Mattakkuliya in 1975, and in Trincomalee in the year 1993, this was established as the National Institute of Fisheries and Nautical Engineering from December 20, 1999, through the National Institute of Fisheries and Nautical Engineering Act in 1999, and two new Fisheries and Nautical Engineering Colleges were developed in Galle in the

year 2006, and in Kalutara North in the year 2008. Likewise, the Vocational Training Division is implemented in 08 regional centers covering various regions in Sri Lanka, and together with the Higher Education Division which consists of two faculties; the Ocean University of Sri Lanka is engaged in the role of providing the human resources needed for research in the fisheries, marine and maritime sectors in Sri Lanka.

With the commencement of awarding degree programs in the year 2001, the degree programs of B.Sc. in Fisheries and Marine Science, B.Sc. in Marine Engineering, and B.Sc. in Vessel Building and Naval Architecture were gazetted and published as government-recognized degree programs in the year 2003.

With the purpose of expanding higher education opportunities of the Ocean University of Sri Lanka for the students who have passed the Advanced Level examination in all subject streams including Commerce and Arts, the B.Sc. In Maritime Transportation Management and Logistics degree program was commenced in the year 2014 and the B.Sc. in Coastal and Marine Resources Management degree program was commenced in the year 2015.

The Ocean University of Sri Lanka Act, No. 31 04 2014 was passed by repealing the National Institute of Fisheries and Nautical Engineering Act of 1999, and having opened up more higher education opportunities for children of the nation, the Ocean University of Sri Lanka was established as a complete university in the year 2015.



04.Higher Education Division

In the year 2021,six Degree programs were implemented under the Higher Education Division of the Ocean University of Sri Lanka, including the inauguration of a Bachelor of Technology degree program.Under the Faculty of Fisheries and Ocean Sciences, B.Sc in Fisheries and Marine Science, B. Tech. in Aquaculture and Seafood Technology and B.Sc in Oceanography Degree programs are being conducted, and under the Faculty of Engineering and Management, B. Sc. in Marine Engineering, B.Sc. in Maritime Transportation Management and Logistics, B. Sc. in Coastal and Marine Resources Management Degree programs are being conducted. Starting from the year 2017 the Degree Programs conducted by the university have been exempted from charging fees. Admission to the B.Sc. in Marine Engineering and B.Sc. in Fisheries & Marine Science has done based on Z-score while admission to the B.Sc. in Maritime Transportation Management & Logistics and B.Sc. in Coastal and Marine Resources Management, B.Sc. in Oceanography has done based on the results of the Aptitude Test.







- ❖ The Vocational Training Division of the Ocean University of Sri Lanka successfully conducted a live documentary program related to the field of aquaculture and aquatic resource management for 256 persons to mark the occasion of National Skills Day in July 2021.
- ❖ Making arrangements to obtain professional membership of the Chartered Institute of Logistics and Transportation Membership for 40 students pursuing the National Diploma in Aquaculture Aquatic Resource Management NVQ 5 course at the Panadura Regional Center.
- ❖ Providing of the opportunity to pursue B.Tech Degree Program of the Higher Education Division for the students who are following NVQ 5 courses at the Vocational Training Division of the Ocean University of Sri Lanka.
- ❖ The Line Ministry has granted 1627 overall kits to university apprentice students in July 2021 and distributed those kits among students.
- ❖ Providing fishing vessel operator training for 427 multi-day fishing vessel operators all over the island.

5.2 Measures taken to enhance student participation

- ❖ To make the fishing community aware of the courses and to provide opportunities for their children to pursue courses.
- ❖ Taking measures to increase student enrollment for the courses by publishing detailed information about the courses in newspapers, television and electronic media to educate service seekers island-wide.
- ❖ Implementing of awareness programs for students and teachers in public schools in their respective areas by the Regional Centers.
- ❖ Educating the public by presenting exhibition stalls for local and national level exhibitions.

Due to the effect of the COVID-19 global pandemic situation on Sri Lanka as well, it had been unable to complete the academic activities of the students admitted, and a situation has arisen where the overall annual training targets could not be met.

6. Administration Division

The Progress of the Sub Divisions of the Administration Division is as follows.

5. Conducting of Efficiency Bar examinations, which have been delayed for many years, in Driver and equivalent grades and Management Assistant and equivalent grades belonging to UPL and UMN service categories and granting their grade promotions.
6. Granting of internal promotions, which have been delayed for many years, of Driver and equivalent grades and Management Assistant and equivalent grades belonging to UPL and UMN service categories.
7. Providing internal promotions of academic staff, which have been delayed for many years.

8. All members of the academic staff were directed to the training course (of 06 months) on teaching and made necessary arrangements to complete the training activities.

9. The academic and non-academic cadre had been approved in the year 2016 and necessary measures have been taken to increase it according to the current requirement and the approval in that regard is to be received in the year 2022.

10. Streamlining the administrative and clerical work of the Human Resource Development Division in such a way that the Marine Engineering Degree program and Engine Rating and Deck Rating Diploma Courses can obtain ISO 9001 standard certificates.

11. Direct 03 employees to pursue postgraduate diploma courses under training activities required for academic and non-academic staff.



Report of the Auditor General on the Financial Statements and Other Regulatory Requirements of the Ocean University of Sri Lanka for the year ended 31 December 2021 in terms of Section 12 of the National Audit Act No. 19 of 2018

1. Financial Statements

1.1 Qualified Opinion

The audit of financial statements of the Ocean University of Sri Lanka for the year ended 31 December 2021 comprising the statement of financial position as at 31 December 2020 and the statement of financial performance, statement of changes in equity and cash flows statement for the year then ended and notes to the financial statements and a summary of significant accounting policies and other explanatory information was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with provisions of the Finance Act No 38 of 1971 and National Audit Act, No.19 of 2018. In terms of the Article 154(6) of the Constitution of the Democratic Socialist Republic of Sri Lanka, my report will be tabled in the Parliament in due course.

In my opinion, except for the effects of the matters described in the Basis for Qualified Opinion of my report, the financial statements give a true and fair view of the financial position of the Ocean University of Sri Lanka as at 31 December 2021, and of its financial performance and cash flows for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards.

1.2 Basis for Qualified Opinion

- a) Since the basic expenditure of Rs. 1,513,936 incurred in the year under review for the building to be constructed under KOICA capital provisions had been written off as training expenditure instead of accounting that as ongoing works, it had been overstated the deficit and understated the ongoing works in the financial statements.
- b) Since action had not been taken to remove the advance balance amounting to Rs. 382,573, which was settled in the year 2020 from accounts, the balance of the advance account had been overstated by that amount in financial statements.
- c) Since the retention money amounting to Rs.300,954 deducted when making payments to the contractor in the year 2020 had been deducted from the advance account instead of crediting it to the retention account, advance balance and the retention balance had been understated in financial statements by that amount as at December 31, 2021.
- d) Even though accrued expenses amounting to Rs. 6,155,458 as at December 31, 2020 had been settled, information in that regard had not been presented for auditing.

I conducted my audit in accordance with Sri Lanka Auditing Standards (SLAuSs). My responsibilities, under those standards are further described in the Auditor's Responsibilities for the Audit of the financial statements section of my report. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

1.3 Other information included in the Annual Report 2021 of the Ocean University of Sri Lanka

Other information means the information included in the Annual report 2021 of the Ocean University of Sri Lanka obtained by me prior to the date of this audit report but not included in my audit report in that regard. The management is responsible for such other information.

Other information is not covered by my opinion on the Financial Statements and I do not declare any assurance or opinion in that regard.

My responsibility regarding my audit on the Financial Statements is to read, if it is able to obtain the other information identified above, and consider them whether quantitatively

inappropriate with the financial Statements or according to my knowledge acquired during the audit, or in a separate way.

If I conclude that the other information is indicated with quantitative errors, based on the other information obtained by me before the date of this Audit Report and on the activities done by me, it is required to report that matter by me. I do not have any to report in this regard.

1.4. Responsibility of Management and Other Related Parties for the Financial Statements

The management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial Statements that are free from material misstatements whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Ocean University's ability to continue as a going concern, disclosing matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Ocean University or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Ocean University's financial reporting process.

As per Sub-section 16 (1) of the National Audit Act, No. 19 of 2018, the Ocean University is required to maintain proper books and records of all its income, expenditure, assets and liabilities, to enable annual and periodic financial statements to be prepared of the University.

1.5 Auditor's Responsibility for the Audit of the Financial Statements

My objective is to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Sri Lanka Auditing Standards will always detect a material misstatement when it exists.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Sri Lanka Auditing Standards, I exercise professional judgment and maintain professional skepticism throughout the audit. I also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the management.
- Conclude on the appropriateness of the management's use of the going concern basis of accounting based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Ocean University's ability to continue as a going concern. If I conclude that a material uncertainty exists, I am required to draw attention in my auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify my opinion. My conclusions are based on the audit evidence obtained up to the date of my auditor's report. However, future events or conditions may cause the University to cease to continue as a going concern.

- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

I communicated with those charged with governance regarding, among other matters, significant audit findings, including any significant deficiencies in internal control that I identify during my audit.

2. Report on Other Legal and Regulatory Requirements

2.1 National Audit Act, No. 19 of 2018 includes specific provisions for following requirements.

2.1.1 Apart from the impact made by the matters described in the Basis for Qualified Opinion of my report, as per the requirement of the section 12 (a) of the National Audit Act, No. 19 of 2018, I have obtained all the information and explanation that required for the audit and as far as appears from my examination, proper accounting records have been kept by the University.

2.1.2 The Financial Statements presented by the University are consistent with the preceding year as per the requirement of section 6 (1) (d) (iii) of the National Audit Act, No. 19 of 2018.

2.1.3 The Financial Statements presented include the recommendations made by me in the previous year as per the requirement of section 6 (1) (d) (iv) of the National Audit Act, No. 19 of 2018.

2.2 Based on the procedures performed and evidence obtained was limited to matters that are material, nothing has come to my attention;

2.2.1 To state that any member of the governing council of the University has any direct or indirect interest in any contract entered into by the Authority which are out of the normal cause of business as per the requirement of section 12 (d) of the National Audit Act, No. 19 of 2018.

2.2.2 To state that it has not complied with any applicable written law, general and special directions issued by the Council of the University as per the requirement of section 12 (f) of the National Audit Act, No. 19 of 2018 other than the below mentioned observations.

2.2.3 To state that the university has not performed according to its powers, functions and duties as per the requirement of section 12 (g) of the National Audit Act, No. 19 of 2018.

2.2.4 To state that the resources of the Ocean University of Sri Lanka has not procure and use in an economical, efficient and productive manner within the durations in conformity with relevant rules and regulations as per the requirement of section 12 (h) of the National Audit Act, No. 19 of 2018.

2.3 Other Matters

- (a) Due to non-rectifying lapses prevailed in the room allocated in 2014 for continuing the welding workshop of the new building where the Negombo College is functioning which was modified under the Sri Lanka Sectoral Development Project (SSDP), it had been unable to commence and continue the workshop and the course until the audited date of March 31,2022. 18 types of welding equipment purchased at a cost of Rs. 1,595,745 for that course had been in an inactive stage due to the non-commencement of the course.
- (b) Although two vessels that had been anchored in the jetty belonging to the Negombo College had been inactive since 2004 to the year under review, approximately an amount of Rs. 200,000 per year had been paid for guarding those having deployed two employees.
- (c) Action had not been taken to recover nine (9) balances amounting to Rs. 15,506,595 receivable for a number of years by the end of the year under review.
- (d) i) For the purpose of developing classrooms, lecture halls, and laboratory facilities, an additional provision of Rs. 300 million had been granted in the year 2016 under budget proposals for constructing a five-storied building at the Mattakkuliya Head Office, an amount of Rs. 6,494,107 had been incurred for the preparation of estimates and soil testing in the year 2016. However, due to not taking measures for constructing the relevant building as of the audited date of December 29, 2021, that expense had been a no purposive expense.

ii) Further, without taking action to construct the said building, a building had been obtained on rent from an external party since the year 2018, and had incurred a total expenditure of Rs. 109,942,547 including Rs. 96,444,819 as building rent and Rs. 13,497,728 as water, electricity and other expenses as at December 31, 2021.

(e) i) Action had not been taken to vest the Negombo Regional Centre land of the Ocean University of Sri Lanka with an extent of 4 ½ Acres until the audited day of March 31, 2022.

ii) After completion of the contract relevant to the new building constructed on that building in the year 2014 having incurred an amount of Rs. 28,843,897/- under the Sri Lanka Sectoral Development Project (SSDP) Funds, its Assistant Director had informed the Director (Training) and the Registrar in five occasions from the year 2015 to 2017 that the defects prevailed there should be rectified by the contractor. However, those defects had been rectified through a new contractor and had been paid an amount of Rs. 3,571,196/- in the year 2021.

Clarification Report for the Report of the Auditor General on the Financial Statements and Other Regulatory Requirements of the Ocean University of Sri Lanka for the year ended 31 December 2021 in terms of Section 12 of the National Audit Act No. 19 of 2018

Financial Statements

1.2 Basis for the opinion.

- a) Having paid attention to the matters pointed out in the audit query, necessary instructions have been given to rectify the basic expenditure of Rs. 1,513,936 which had been incurred related to the KOICA Project in the year, under review under an ongoing works of the building constructions related to that project, and to present the final accounts for the year 2022.
- b) Having paid attention to the audited fact, action has been taken to present the relevant adjustment in the 2022 accounts.
- c) Having paid attention to this matter, action has been taken to rectify the relevant adjustment in the 2022 accounts and has submitted to you.
- d) Action had been taken and settled regarding the accrued expenditure balance, and a formal internal control procedure has been introduced from the year 2001 to maintain those documents properly. And it has been instructed to the relevant Divisional heads to scrutinize information that are submitted to the Government Audit Office in the future.

2.3 Other matters

- a. On the recommendations made at the 2022 (01) Institutional Audit and Management Committee meeting regarding the balances pointed out by the query, a committee consisting with 05 persons had been appointed to settle those balances, and action would be taken in future based on the recommendations made by the Audit and Management Committee considering the recommendations of the said appointed committee.

- b. It should be corrected that the commencement of the welding workshop of Negombo College had been planned not in the refurbished building mentioned in the audit query but in the old building.

As it had been unable to address the deficiencies for commencing the workshop for the said course, two types out of those training equipment were given to the Mattakuliya College, and few others were used for practical training activities of the courses on Vessels mechanic and Underwater Welding. Instructed to provide the remaining equipment to other colleges.

- c. Payment of overtime for vessel guarding has been suspended by now, and security services are implemented under a roaster. A committee has been appointed to obtain recommendations on the training vessels of the Ocean University, and it is expected repair/ dispose or taking further action as per the recommendations of the said committee.
- d. This matter had been discussed at the Audit and Management Committee meeting, and a committee had been appointed to obtain a report on those deficiencies, and it is expected to take further action as per those recommendations.
- e. I) Although Rs.300 million had been allocated by the Department of National Budget in the year 2016, as the said amount did not receive in the said year, it had been unable to commence constructions of the five storied building.

Since it has been planned to construct a building complex on this land under the KOICA project, the data relevant to the soil testing were used for the EIA report of that project. The data on soil testing are required for constructions of the said project, and it is expected to obtain the cost incurred in that regard from the KOICA Project.

II) Although constructions could not be carried out in Crow Island Premise due to financial policies made by the government, it had to obtain a nearby building on rent basis to increase student admissions, to recruit new lecturing staff and to expand classrooms, libraries, and computer laboratories. A formal approval in that regard had been obtained.

f. I) The title of the Negombo Unit is in the name of the institute existed at that time, and it was instructed to vest that land to Ocean University of Sri Lanka after obtaining survey orders. Similarly, I instructed the Unit Heads to commence the vesting activities of the lands on which the other regional centers are located also to the Ocean University.

II) Although the preparation of architecture plans and estimates for the construction activities of this land had been done by a consultant nominated by a Department of Civil Engineering of the University of Moratuwa, the building could not be used properly / used for academic purposes. Therefore, having prepared Bills of Quantities including additional works that were essential and not included in the previous estimates, the works were get done by this new contractor who was selected following the procurement procedure.

Similarly, retention money of the contractor who carried out constructions under the SSD project had been expired, the renovations were get done by this new contractor. The State Engineering Corporation provided the consultancy services and the prepared Bills of Quantities for these renovations / constructions, as well.
